Colin Chandler, Managing Director and founding partner of onetwo Accounting, has more than twenty-three years' experience in Accounting, Management and IT across diverse industries.

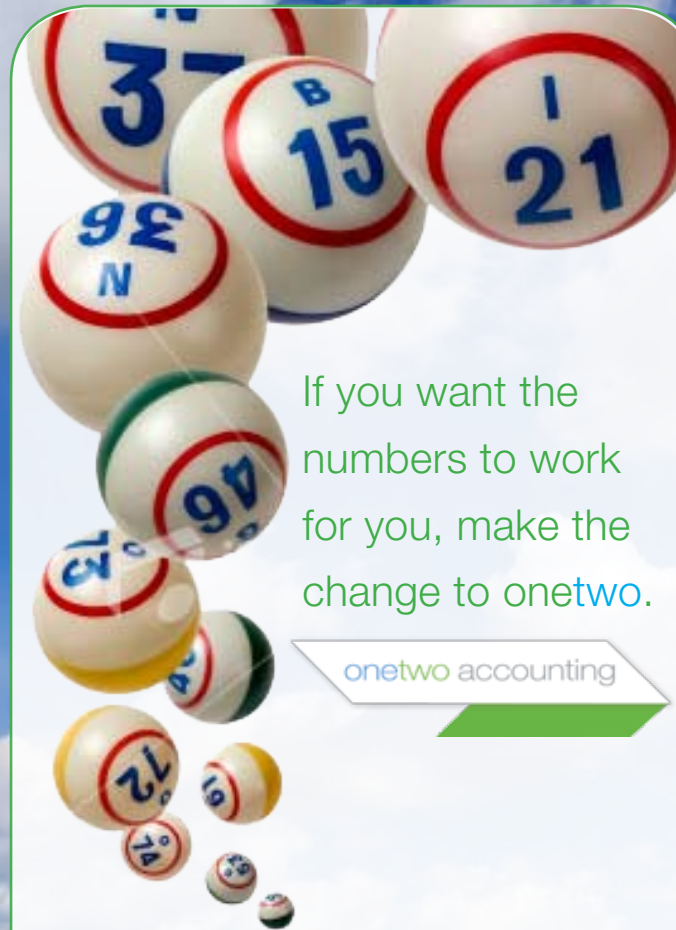
After qualifying in Accounting, Colin joined McDonald's and quickly moved up the ranks to General Manager. While there, he developed new software that computerised a manual inventory control system.
